CORRIGENDUM

NO.EDN.190/2011/Pt./220

Dated Shillong the 22nd November, 2018

In partial modification of this Department's Notification No.EDN.190/2011/Pt/190, dated 8th October, 2018, the following are hereby notified based on the Notification No.F.No.61/03/20/2010/NCTE/(N&S) dated 23.08.2010, Amendment No.7.No.61-1/2011/NCTE(N&S) dated 29.07.2011 and Amendment No.7.No.NCTE- Reg/012/16/2018 dated 28.06.2018

I. The Meghalaya Teacher Eligibility Test for Elementary School Teachers

- (i) There shall be an Eligibility Test for all persons desirous of applying for recruitment as elementary school teachers (Classes I to VIII) and for teachers appointed to teach classes I to VIII after the NCTE Notification dated 23.08.2010. This would apply to schools referred to in clause (n) of Section 2 of the RTE Act 2009, which include-
- (a) A school established, owned or controlled by the appropriate Government or a local authority, referred to in sub-clause (i) of clause (n) of section 2 of the RTE Act;
- (b) An aided school receiving aid or grants to meet whole or part of its expenses from the appropriate Government or the local authority, referred to in sub-clause (ii) of clause (n) of section 2 of the RTE Act; and
- (c) An unaided school not receiving any kind of aid or grants to meet its expenses from the appropriate Government or the local authority, referred to in sub-clause (iv) of clause (n) of section 2 of the RTE Act;
- (ii) The Eligibility Test shall be conducted Sub-Division wise by the Education Department through the Directorate of Educational Research & Training.

II. Eligibility to appear in the Test

Minimum Qualifications:-

(i) Class I- V

Higher Secondary (or its equivalent) with at least 50% marks and 2 year Diploma in Elementary Education (by whatever name known)

OR

Higher Secondary (or its equivalent) with at least 45% marks and 2 year Diploma in Elementary Education (by whatever name known), in accordance with the NCTE (Recognition Norms & Procedure), Regulations, 2002

OR

Higher Secondary (or its equivalent) with at least 50% marks and 4 year Bachelor of Elementary Education (B.El.Ed)

OR

Higher Secondary (or its equivalent) with at least 50% marks and 2 year Diploma in Education (Special Education)

OR

Graduation and two year Diploma in Elementary Education (by whatever name known)

OR

Graduation with at least 50% marks and Bachelor of Education (B.Ed)

OR

A person who is pursuing any of the Teacher Education Courses (recognized by the NCTE or the RCI, as the case may be) specified in the NCTE Notification dated 23rd August, 2010.

(ii) **Classes VI-VIII**

Graduation and 2 year Diploma in Elementary Education (by whatever name known)

OR

Graduation with at least 50% marks and 1 year Bachelor in Education (B.Ed)

OR

Graduation with at least 45% and 1-year Bachelor in Education (B.Ed), in accordance with NCTE (Recognition Norms and Procedure), Regulations issued from time to time in this regard.

OR

Higher Secondary (or its equivalent) with at least 50% marks and 4-year Bachelor in Elementary Education (B.El..Ed)

OR

Higher Secondary (or its equivqlent) with at least 50% marks and 4 year B.A/ B.Sc.Ed or B.A. Ed./ B.Sc. Ed.

OR

Graduation with at least 50% marks and 1 year B.Ed. (Special Education)

OR

A person who is pursuing any of the Teacher Education Courses (recognized by the NCTE or the RCI, as the case may be) specified in the NCTE Notification dated 23rd August, 2010.

III. Age limit :

- (i) The candidate should not have crossed 32 years of age (relaxable up to 37 years in the case of SC/ST/ Differently Abled candidates) as on the first day of the first month of the year in which the advertisement was made.
- (ii) In the case of candidates already in government service, he/she should have first entered service within the age limit mentioned in Clause (i) above and he/she shall have to obtain a No Objection Certificate (NOC) from the concerned office/Department for applying & appearing for the examination.
- (iii) In respect of Candidates employed in aided schools and contractual teachers, the age limit of 35 years (relaxable by 5 years in case of ST/SC Candidates) on the first day of the year as required, including those candidates employed in unaided schools, is hereby exempted.

Note:

1. Relaxation up to 5% in the qualifying marks in the minimum Educational Qualification for eligibility shall be allowed to the candidates belonging to reserved categories, such as SC/ST/OBC/Differently Abled.
2. Diploma /Degree Course in Teacher Education recognized by the NCTE only shall be considered. However, in case D.Ed (Special Education) and B.Ed (Special Education), a course recognized by the RCI only shall be considered.
