The Directorate of Educational Research & Training (DERT) is pleased to inform all Government Primary, Upper Primary and Secondary Schools in Meghalaya that the CM IMPACT Meghalaya Class Readiness Programme (MCRP) will be implemented for the second consecutive year. All teachers are required to mandatorily log in and complete the Online Course, for which certification will be issued upon successful completion.

In accordance with the **Academic Calendar 2026** issued by the Education Department, Government of Meghalaya (No. EDN.168/2010/177 dated 10 December 2025), schools are to implement the MCRP as per the following schedule:

- **Classes I to V:** 9 February 2026 to 6 March 2026
- **Classes VI to X:** 9 February 2026 to 27 February 2026
