Applications for Post Matric Scholarship are to be submitted on-line through this URL www.scholarships.gov.in. Print out of duly filled-in application forms are also to be submitted to their respective institution. alongwith all supporting documents. Only Online application under Post Matric scholarship Scheme will be accepted and no request for an Offline application will be entertained. It may be noted that submission of Aadhaar is Mandatory.
