- Promote community participation and stakeholder ownership in educational initiatives, school improvement efforts, and learning enhancement programmes.
- Develop and implement communication strategies, awareness campaigns, public engagement activities, and outreach programmes to strengthen educational outcomes.
- Facilitate two-way communication by collecting feedback, suggestions, innovations, concerns, and best practices from stakeholders and placing them before the Department for appropriate action.
- Promote positive narratives around education and highlight exemplary practices, outstanding schools, teachers, students, and community-led initiatives.
- Support the Department in strengthening digital communication through websites, social media platforms, newsletters, publications, podcasts, videos, and other communication channels.
- Assist in building partnerships with media organisations, academic institutions, development partners, professional bodies, alumni networks, and community organisations for advancing educational objectives.

- Encourage transparency, accountability, and public trust through timely dissemination of authentic information relating to educational programmes and outcomes.
- Recommend measures for improving stakeholder engagement, public communication, grievance redressal, and citizen participation in the education sector.
- Perform any other function assigned by the Education Department from time to time in furtherance of educational development and stakeholder engagement.

Meetings:-

- The Team shall meet at least once every week (Physical & Virtual) or as and when required. The Team Lead shall convene meetings and maintain records of proceedings and action taken.
